Project Need and Purpose

Project Need (What problems are we trying to address?):

 Lack of north-south connectivity on Bicentennial Boulevard between Trenton Road and SH 107, and between the communities located in the proposed project's vicinity.

Project Purpose (What are we trying to do?):

- Provide new north-south connectivity between Trenton Road and SH 107.
- Improve connectivity to intersecting local streets and surrounding areas in the City of McAllen.



Project Details

- The existing Bicentennial Boulevard roadway would be extended. Proposed improvements include construction of:
 - Four-lane, curb and gutter roadway
 - Left turn lanes at cross streets
 - Continuous sidewalks
 - An underground storm drain system with drainage outfalls
- New & upgraded traffic signals at the following intersections:
 - Auburn Avenue
 - Frontera Road
 - Northgate Lane
 - Freddy Gonzalez Drive
 - Sprague Road

Right-of-Way Acquisitions

Early right-of-way (ROW) acquisitions:

Approximately 40.1 acres

Anticipated ROW acquisitions:

- Approximately 1.9 acres
- Would impact six parcels
- Would result in the displacement of one mobile home, one residential structure, and one vacant commercial structure near SH 107

Environmental Impacts

An environmental study was conducted and concluded the following:

Noise Impacts:

- Four noise barriers are proposed that were determined to be both feasible and reasonable.
- Would require 0.2 acre of permanent easements and 0.6 acre of temporary construction easements.
- A traffic noise workshop will be scheduled in Summer 2018. Property owners adjacent to each proposed noise barrier would be notified and be given the opportunity to vote for or against the construction of the proposed noise barrier adjacent to their property.

Applicability of Section 4(f) and Chapter 26:

- Hidalgo County Irrigation District #2, or the Louisiana Rio Grande Canal Company Irrigation System, is listed as a National Register of Historic Places historic district.
- The proposed improvements meet the requirements for a Section 4(f) de minimis impact finding and do not constitute an adverse effect.

Environmental Impacts, Continued

An environmental study was conducted and concluded the following:

Vegetation Impacts:

- The proposed project would impact approximately 12.9 acres of Disturbed Prairie; 6.9 acres of Tallgrass Prairie, Grassland; 3.3 acres of Agriculture; and 1.3 acres of Riparian vegetation.
- No waters of the U.S., including wetlands, or floodplains would be impacted.
- The proposed project would not result in adverse impacts to low-income or minority populations, archeological or other natural resources, nor would it result in air quality or hazardous material impacts.

Conclusion: Studies, analyses, and evaluation of the proposed project indicate no significant impacts.
