RESOLUTION NO. 2016 – 07
IMPLEMENTING ANNEXATION PROCEDURES

STATE OF TEXAS
COUNTY OF HIDALGO
CITY OF MCALLEN

WHEREAS, THE City of McAllen is a home of municipal corporation of Hidalgo County, Texas; and

WHEREAS, an enumerated power of the City of McAllen under its Charter is the annexation of territory within its extraterritorial jurisdiction; and

WHEREAS, the Board of Commissioners of the City of McAllen has established a procedure for the annexation of territory in Ordinance No. 1981-96, said ordinance setting out in detail the procedure for voluntary and City initiated annexation; and

WHEREAS, the Board of Commissioners of the City of McAllen deems it in the best interest of the health, safety, and welfare of those persons residing within those area shown in Exhibit A attached hereto, that said areas be annexed into the corporate limits of the City of McAllen, thereby affording those persons residing therein to have all the rights and privileges to which they are entitled.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF MCALLEN, TEXAS, THAT:


SECTION 1: The Director of Planning of the City of McAllen is hereby authorized and directed to implement procedures required under State Law and the Charter and ordinances of the City of McAllen to annex the tracts of land as hereinafter described in Exhibit A attached hereto.

SECTION 2: The Director of Planning is further directed to comply with the procedures for such annexations as prescribed in Ordinance No. 1981-96.








PROPOSED ANNEXATION LOCATION MAP
