SUBJECT: FY 24 Certified Local Government Grant Application Update

**BACKGROUND:** The Texas Historical Commission (THC), with federal funds through the National Park Service and U.S. Department of the Interior, administers the Certified Local Government (CLG) Grant Program. The CLG grant period is October 1, 2023 to September 30, 2026 with grants being awarded in 2024. The City of McAllen is a Certified Local Government and is eligible to apply to the grant program.

The Planning Department, with recommendations from HPC and the City Commission, applied for a \$5,000 grant. In January, the THC notified Planning that it had not been chosen as an application to be awarded. With \$370,930 in grant requests and only \$197,000 available, it was quite competitive.

Alongside with our notification we received feedback, which will help us for future funding.
