**Sec. 86-91. - Definitions.**

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Garage or porch sale* means a sale of used merchandise or personal property from any residence.

*Occupant* means, jointly and severally, all those who occupy premises. For purposes of this article, there is only one "occupant" of any premises at any given time.

**Sec. 86-92. - Permit required; limitations; violation and penalties.**

(a) The owner or occupant of a residence shall obtain a permit from the health and code enforcement department before conducting a garage or porch sale the cost of which permit shall be \$20.00.

(b) The owner or occupant of a residence wishing to conduct thereon a porch or garage sale shall be limited to three permits in any calendar year, each to cover a period of time not to exceed three consecutive days. No permit shall be granted to the same owner or occupant within 30 days of the previous permit for such residence.

(c) It shall be unlawful for the owner or occupant of a residence to conduct thereon a garage or porch sale without having first obtained a permit as provided by this section.

(d) Anyone who violates this section shall, upon conviction thereof, be punished as prescribed in [section 1-14](#).

- Signs are not allowed except for one (1) sign on the property where the sale is being held. (McAllen Code 130-82, 70-10, and 130-81 (3))
  - Limit of three (3) permits in any calendar year. Permits may not exceed three (3) consecutive days. (McAllen Code 86-92(b))
  - No Permit will be granted to the same location within thirty (30) days of previous permit, and only used merchandise or personal property may be sold. (McAllen Code 86-92(b))
