2025 McAllen National Incident-Based Reporting System (NIBRS) Crime Estimate Released

The City of McAllen participates in the US Department of Justice (DOJ) FBI Uniform Crime Reporting (UCR) System, a nationwide statistical data reporting effort.

The DOJ FBI Summary Reporting System (SRS), commonly known as the Uniform Crime Reporting (UCR), transitioned to the National Incident-Based Reporting System (NIBRS) beginning January 1, 2021.

Additionally, the Texas Legislature passed legislation that requires this reporting change.

HB 11, Texas 84th Regular Session, effective 09/01/2015, in part, provides that:

Sec. 411.054. INCIDENT-BASED CRIME STATISTICS REPORTING GOAL.

(a) The department shall establish a goal that, not later than September 1, 2019, all local law enforcement agencies: (1) will have implemented an incident-based reporting system that meets the reporting requirements of the National Incident-Based Reporting System of the Uniform Crime Reporting Program of the Federal Bureau of Investigation; and (2) will use the system described by Subdivision (1) to submit to the department information and statistics concerning criminal offenses committed in the jurisdiction of the local law enforcement agency.

Reporting under the traditional UCR format reflects occurrences of eight (8) crime categories (including Arson) called Part 1 Crimes.

Reporting under the NIBRS format reflects 24 offense categories of 52 reportable Group A offenses and 10 Group B offenses.

The City of McAllen's Uniform Crime Reporting (UCR) transitioned to the National Incident-Based Reporting System (NIBRS) since January 1, 2021.

We anticipate releasing our 2025 McAllen National Incident-Based Reporting System (NIBRS) Crime report on Friday, January 16, 2026. Generally, the report will reflect the following NIBRS offense information:

- *At the end of 2025, McAllen’s Crime Volume decreased 10.4%.*
- *At the end of 2025, McAllen’s Crime Rate decreased 11.4%.*
- *At the end of 2025, McAllen recorded its lowest crime in the last forty (40) years.*
- *At the end of 2025, McAllen’s 2025 reported crime was less than its 1985 reported crime.*
- *At the end of 2025, McAllen recorded its nineteenth (19th) annual crime reduction in the last twenty-three (23) years.*
- *McAllen’s crime high of 12,591 offenses was reported in 1995.*
- *The City of McAllen has reduced crime 81.4% from its crime high of 1995; and*
- *McAllen’s crime incidence in 2025 was 18.6% of its reported crime high of 1995.*

We express our sincere appreciation to every member of the McAllen Community for entrusting us with their public safety.
