Multiple Arrests in Law Enforcement Initiative

McAllen Police Officers conducted a law enforcement initiative that resulted in the arrest of 13 persons. On April 21, 2025, four (4) females were arrested for engaging in the criminal offense of Prostitution. On April 22, 2025, three (3) males were arrested for Solicitation of Prostitution. Two (2) additional males were arrested on April 23, 2025 and charged with Solicitation of Prostitution. Thursday, April 24, 2025, concluded the initiative with the arrest of four (4) males, each charged with Solicitation of Prostitution.

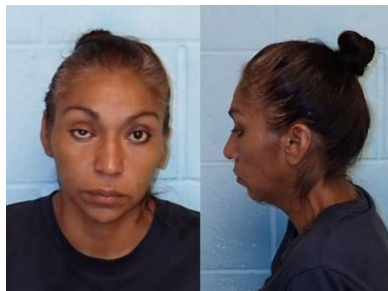
