### **McAllen Officer Injured in Response to “Shots Fired” U.S. Customs and Border Protection Building**

**Nature of Call-For-Service (CFS):** Disturbance (Shots Fired In-Progress).

**Location:** 2300 Block South Main Street.

**Date:** 07/07/2025.

**Time:** 5:53 AM.

Reporting person(s) (RPs) reported "30-60 shots heard". Through multiple CFS, RPs reported continued "shots" at location.

At 5:54 AM, RP reported "male [suspect] ...walking in front of Annex of BP [Border Patrol] Station.

At 5:55 AM, RP reported "male [suspect] LSW [last seen wearing] mask ...active shooter ...has an AR [assault rifle].

At 5:56 AM, RP reported "male is shooting in at the door ...lots of shots fired".

At 5:57 AM, Responding Officer Ismael Garcia reported "possibl[y] shot".

At 5:58 AM, RP reported "alots of shots heard inside ...BP Station".

At 5:59 AM, RP and Responding Officer(s) reported "one shooter down".

Responding Officer(s) determined one (1) suspect arrived at the location in a white vehicle displaying Michigan license plates. Upon arriving at the location, the suspect opened gunfire at Border Protection (BP) personnel and the BP facility. BP Agents at the BP Station under assault, engaged the suspect, returned fire and fatally wounded the suspect.

Responding Officer(s) and US DOJ FBI on scene determined that incident would be investigated federally. Reasoning included that incident involved an Assault on Federal Officer, Assault on Federal Building and a Federal Officer Involved Shooting. McAllen PD and TX DPS assisted US DOJ FBI with crime scene processing, evidence collection and rendering safe the scene.

The McAllen Bomb Response Unit rendered safe the suspect vehicle and various backpack type carry-ons in the suspect vehicle.

The suspect was tentatively identified as Ryan Louis Mosqueda, 27 years of age with a last known address at Ludington, Michigan. The suspect was reported as a "Missing Person" at Weslaco earlier this morning at approximately 4:13 AM. The suspect was declared deceased on scene (DOS) by JP Ramon Segovia. Ric Brown Funeral Services took custody of the suspect's body.

McAllen Police Officer Ismael Garcia suffered a bullet wound to his right leg. Officer Garcia underwent treatment for his injury at a local medical facility. Officer Garcia is a 10-year Officer at the McAllen Police Department.
