

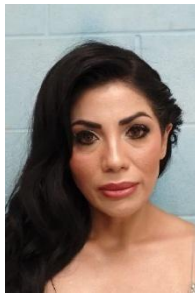

Medical Distress Call Results in Furnishing Alcohol Charge

Nature of Call-For-Service (CFS): Medical Assistance

McAllen Emergency Communications received a call for medical assistance in reference to “15 YOA [years of age] fem [female] drank alcohol and is vomiting.” Emergency Communications was advised at 10:00 PM that, “EMS [Emergency Medical Services] req [requesting] assistance,” and, “[female] breathing but eyes are closed.” McAllen Police Officers were dispatched to the 4100 block of Colbath Avenue. At 10:03 PM, the Reporting Party (RP) advises, “she can’t breathe,” and “female throwing up.”

Responding Officers observed the minor female “to be in and out of consciousness.” Officers report two minors, under the age of 21, had “unrestricted available access” to alcoholic beverages in a room at the event and consumed directly from the bottles, leading to the medical assistance call.

Officers were able to determine the source of the alcoholic beverages at the event. Officers identify **Jeanett Garza** and **Jose Garza** as having purchased the alcoholic beverages and storing them inside a room used by the minors at the event.

During the course of this investigation, Officers issued one citation for **Consumption of Alcohol by a Minor**. The minor suspected of alcohol consumption was released to a responsible party. The second minor was transported to a local hospital for emergency medical care.

Citations for these violations are a promise to appear in the McAllen Municipal Court for appropriate disposition. Each citation has been forwarded to the McAllen Municipal Court for processing and adjudication.

The McAllen Police Department continues to investigate and identify any person who participated in this offense. The Department works with local, state, and federal partners to identify these persons. Other charges may be forthcoming.
