## **Organized Crime Suspects Charged**

Nature of Call For Service (CFS): Burglary of Vehicle. Date: January 02, 2023. Time: 1:08 AM. Location: 1800 block of S. 2<sup>nd</sup> St, McAllen, Texas

McAllen Police officers were investigating a burglary of vehicle in the area of the 1800 block of S 2<sup>nd</sup> St, McAllen, Texas. Responding officers observed a black Chevy passenger car leaving the area, as officers conducted a traffic stop, the suspects refused to stop and fled. The suspects were located in the immediate area and apprehended. The suspects were in a stolen vehicle, a Chevy passenger car, that was reported stolen to McAllen Police on January 1<sup>st</sup> 2024. The suspects involved are believed to be involved in organized crime with ties to Mexico.

The McAllen Police Department will continue to combine its efforts with local, state and federal agencies to further resolve these crimes and secure the arrest of the persons involved.
