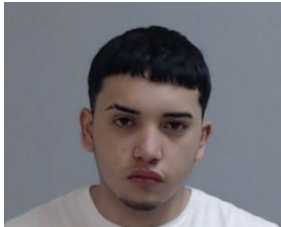

Altercation Results In Shooting

Summary: Reporting person (RP) called to report that her boyfriend had been shot. Responding Officer(s) located the victim at the 1600 Block of Beaumont St. The victim, male approximately 21 years of age, had suffered Shooting wounds to upper body.

Responding Officers established that the disturbance had originated at establishment known as NO MANCHES BUEY at 200 Block of 17th street.

One (1) male person of interest is in custody with determination of charges pending.

The victim was rushed to and remains at local emergency care facility.

Other suspects in this matter remained to be arrested and charged.

This investigation is ongoing with McAllen PD and federal agency.
